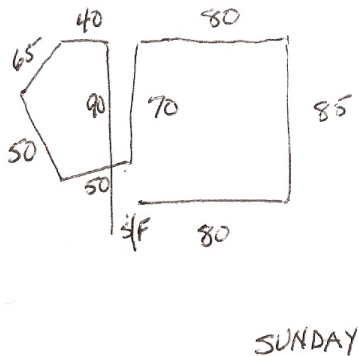
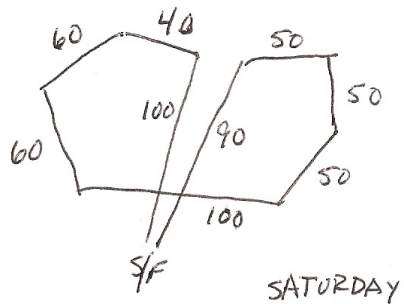

## CONDITIONS OF ENTRY FOR COURSING ABILITY TEST

All dogs run at owner's sole risk.

Dogs must be one year of age or older the day of the test.

**Each dog requires an individual entry form for each test in which it is entered.**

Bitches in season and lame dogs will be refused entry and if presented at inspection, entry fee will be refunded. Spayed or neutered dogs may be entered. Entries will not be accepted without fees, signatures, or the "agreement" found on an official AKC entry form.

Dogs that are overweight or out of condition may be at greater risk for injury or exhaustion. The inspection committee has the authority to disallow a dog's entry. In this case the entry fee will be refunded. Exhibitors should follow their veterinarian's recommendations and insure their dogs have appropriate vaccinations. **You may be asked for proof of rabies, please bring the certificate.**

No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an act of God, a public emergency, or any other cause beyond the control of the club or its members or representatives.

Battery powered continuous loop machines will be used. The lure will consist of plastic strips. Only the Lure Operator, Hunt Master, Judge and handlers of the hounds running in the course in progress will be near the lure machine. The members of CHAMP reserve the right to alter the course plan as required by weather and/or field conditions on the day of the test.

Any person, upon reasonable complaint, may be asked to leave the grounds of the test by the Field Committee and may be disciplined by AKC. Children must be under control of their parent(s) or guardian(s) at all times.

A \$5.00 fine will be assessed on the owner or handler of any dog loose on the field not competing in the course in progress.

## DIRECTIONS

### From the North:

From Interstate 70 in Frederick, MD take Route 340/15 south bear onto 15S at the split. Leesburg is 24 miles, Oatlands is 6 miles south of Leesburg. **The turn is BEFORE Oatlands.** Watch for coursing signs. Turn **LEFT** on to Gap Road and turn right on the access road to the field.

From Washington Beltway take either Route 7 or Dulles Greenway west to Leesburg bypass, south to Route 15 South exit, follow direction above.

### Directions from the South:

Follow Route 15 North toward Leesburg. Oatlands is on the right. **Go past the main entrance to Oatlands.** Turn **RIGHT** on the first road, Gap Road. This is a narrow dirt road. Turn right on the access road to the field.

Please note that there is a driveway before Gap Road from the south. This is the caretaker's drive and is not maintained.

**THE MAIN GATE DOES NOT OPEN UNTIL 9:00 AM. IN THE MORNINGS AND YOU WILL NEED TO ENTER FROM GAP ROAD.**

## THINGS TO KNOW

The field is fenced with typical farm fencing.

Bring your own shade and water.

Food will be available for a donation

**ALL** dogs must be kept on leash or confined unless competing in a course in progress.

Please note that as of January 1, 2015, any dog who relieves itself on course will not pass.

**Running order will be announced the day of the test. If we are not contacted in advance and you do not show up for a test, your monies will be forfeited.**

**Veterans is an optional stake and WILL NOT be offered.**

No practice is planned for either day.
